Dear Ms. Huebl:

The amendment to update the First Aid Statement per PRN 2001-1, submitted in connection with registration under FIFRA section 3(c)(7)(A), is acceptable provided that you:

- 1. Submit and/or cite all data required for registration/reregistration of your product under FIFRA section 3(c)(5) and section 4 when the Agency requires all registrants of similar products to submit such data.
- 2. Submit three (3) copies of your final printed labeling before you release the product for shipment. Final printed labeling means the label or labeling of the product when distributed or sold. Clearly legible reproductions or photo reductions will be accepted for unusual labels, such as those silk-screened directly onto glass or metal containers or large bags or drum labels.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.



INTRODUCTION: Exposure of the larval instars of the cigarette beetle (*Lasioderma semicome*) and tobacco moth (*Ephestia elutella*) to **KABAT**® Tobacco Protector (**KABAT**) prevents adult emergence. **KABAT** contains an Insect Growth Regulator which has no effect on pupae or adult insects. When applied as directed, **KABAT** has sufficient field life under varying tobacco storage conditions to prevent insect population increase.

DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

MIXING AND APPLICATION INSTRUCTIONS: Apply 0.2 pounds (3.9 fl oz) of **KABAT** per 1000 Ib of tobacco. Apply **KABAT** directly to tobacco immediately prior to compaction in hogsheads. Assure complete coverage by using multi-directional sprayers and tumbling. **KABAT** may be applied by using a proportional dilution apparatus or preparation of a dilute spray solution.

Preferred Application Method: Use a proportional dilution apparatus designed or approved by Wellmark International. Adjust the **KABAT** delivery rate to the tobacco flow rate to ensure treatment at the required concentration. Select the **KABAT**/water ratio to achieve adequate coverage and the desired degree of moisture adjustment of the tobacco.

Alternate Application Method: Prepare a spray solution by mixing KABAT with SDA-4 alcohol and water as follows: For each 1000 pounds of tobcco to be treated, add 0.2 lb (3.0 fluid ounces) of KABAT to 2.5 lb (49 fl oz) of SDA-4 alcohol. With agitation, add 7.3 lb of water (112 fl oz) for a total of 10 lb (160 fl oz) of spray solution. Agitate until homogeneous. Use the diluted KABAT spray mixture within 24 hours.
