Label Amendment- add bed bugs Subject:

> Zoecon RF-229 RTU Carpet Pump Spray EPA Registration Number 2724-401 Your submission dated June 6, 2011

The application referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable with the following comments:

- 1. Change "Kills bedbugs and their larvae for up to 14 days" to read "Kills bed bug adults and nymphs for up to 14 days" or "Kills bed bugs for up to 14 days."
- 2. Data for adult and 3rd stage bed bug nymphs are required as a condition of registration. Testing must be conducted on the following surfaces: unpainted plywood, medium pile carpet, and an impervious surface such as ceramic tile or linoleum tile. This study MUST be submitted within 12 months of this letter.
- 3. The language in the first paragraph: "Remove or pick up clothing and other obstacles that prevent thorough inspection and treatment. Remove and sanitize infested bedding, clothing, or other items...etc." may be retained if this product is for consumer use only. If this product is for professional use, the applicator would be responsible for correcting these conditions and the language should be preceded with "Instruct residents to:".

Fleas: Use Zoecon RF-299 RTU Carpet Pump Spray [Brand name] in homes, [garages],[attics], [apartments] and [hotels]. One bottle will treat a surface area equivalent to approximately [3][2] [9' X I2'] [8][4][3][2][10' X 10'] rooms. A fine spray applied uniformly is all that is necessary to kill fleas. Avoid wetting furniture and carpeting. Remove birds and cover aquariums before spraying. For maximum effectiveness treat entire carpeted area. Treat carpets, rugs, drapes and all surfaces of upholstered furniture. Remove old pet bedding and replace with clean fresh bedding after treatment of pet area. Retreat as necessary. Leave treated areas and do not return for at least one hour.

Avoid contamination of food and foodstuffs. Do not use in the edible product areas of food processing plants, restaurants, or other areas where food is commercially prepared, processed, stored, or served.

To kill ticks, roaches, silverfish, earwigs, and ants in the environment, apply directly to pests.

Bed Bugs: Thoroughly inspect areas of suspected bed bug infestation and note potential or actual sites where bed bugs hide. Remove or pick up clothing and other obstacles that prevent thorough inspection or treatment. Remove and sanitize infested bedding, clothing, or other items. **Do not apply to bedding. Wash bedding and dry using medium to high heat to kill bed bugs.**
