Formulation and Labeling Amendment Submitted with Your Subject: Letter Dated 5/13/92 EPA Registration No. 2724-426

The amendments referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act are acceptable subject to the following comments.

1. Your Confidential Statement of Formula dated 6/9/92 will, subsequent to your receipt of this letter and precluding any future formulation amendment approvals, be the basic and only Confidential Statement of Formula used in formulating this product.

Modify the Hazards to Humans and Domestic Animals 2. statements on the label by adding the following language, "May cause eye irritation. Avoid contact with eyes or clothing. Wash thoroughly with soap and water after handling."

3. Item 3 of the notice of registration dated 5/29/92 is no longer applicable due to the subject formulation change.

A stamped copy of the label is enclosed for your records. Submit five (5) copies of the final printed labeling. Your release for shipment of the amended formula and label constitutes acceptance of these conditions.
