Bees must be exposed to the **APISTAN** Queen Tab for 3 days. Bees may be certified apparently free of Varroa mite as long as they are not subjected to reinfestation. Do not use in beehives.

STORAGE and DISPOSAL: Do not contaminate water, food, or feed by storage or disposal. **Storage:** Keep tabs in original unopened package until ready to use. Do not store in direct sunlight. Do not store unused tabs in anything but original package. Do not store unused tabs near pesticides or other chemical substances that could contaminate the tabs and result in bee toxicity. **Disposal:** Do not reuse tabs.
