Dear Ms. Friedli:

The amended labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable.

This approval does not affect any terms or conditions that were previously imposed on this registration. You continue to be subject to existing terms or conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. The next label printing of this product must use this labeling unless subsequent changes have been approved. **You must submit one (1) copy of the final printed labeling before you release this product for shipment with the new labeling**. from the date of this letter under the previously approved labeling until existing stock is depleted **provided the unacceptable label language noted below is stickered over**.

- on page 1 of the label: "or as an animal drug regulated by the Food and Drug Administration (FDA)" and
- on page 2 of the label, in the Directions for Use section: "[or animal drug]" and "[or FDA]"

Affixing a sticker to a container is considered labeling and therefore production as defined in 40 CFR 167.3. Further, 40 CFR 167.20(a)(1) requires any establishment where production occurs to be registered. Affixing a sticker must take place in a registered establishment and must follow all requirements of FIFRA (including FIFRA section 7, 7 U.S.C. 136e, and 40 CFR Part 167 (e.g., relabeling must occur in an EPA registered establishment and relabeling activity must be reported). The sticker itself must meet labeling requirements under 40 CFR Part 156.

Once existing stock is depleted, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR § 152.3.

Should you wish to add/retain a reference to your company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the U.S. Environmental Protection Agency (EPA or the Agency). If the website is false or misleading, the product will be considered to be misbranded and sale or distribution of the product is unlawful under FIFRA section 12(a)(1)(E). 40 CFR § 156.10(a)(5) lists examples of statements the EPA may consider false or misleading. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Offer for recycling if available or reconditioning if appropriate, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.
