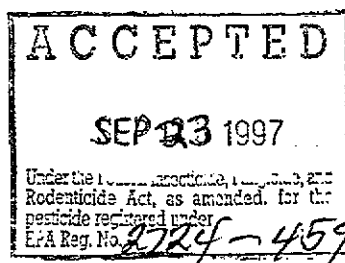

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS - CAUTION: Harmful if absorbed through the skin. Avoid contact with skin, eyes, or clothing. Wash thoroughly after handling. Repeated use of this product may cause skin sensitization. Do not use on puppies or kittens under 12 weeks old. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals, or animals on medication. Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

FIRST AID: If on skin - Remove contaminated clothing and wash affected areas with soap and water. Get medical attention if irritation persists.

If in eyes - Flush eyes with plenty of water. Get medical attention if irritation persists.

Empty entire 2 ounces (4 Tbsp) of concentrate into 1 gallon of water. Rinse concentrate bottle in dip solution. Mix thoroughly. Dip animal by total immersion or pour or sponge dip onto the animal, working it down to the skin until the hair coat is thoroughly saturated. Make sure the entire animal is treated including the head, face, ears, paws, and tail. Allow the dip to dry on the animal. Do not rinse off the dip solution. Reapply every week, if necessary for adult flea control. Diluted dip may be used for up to two weeks following mixing.

STORAGE AND DISPOSAL: Store in original container, away from children. Do not store at high temperatures (greater than 104° F) for prolonged periods. Protect from freezing or high temperatures. Do not reuse empty container. Wrap and put in trash.
