**FOR USE IN THE HOME**

**SHAKE WELL BEFORE USING**

1. Identify areas to be treated, especially those where pets frequent. These are the primary areas where fleas and their eggs are found.

One 12 oz. [16 oz.] can treats 1500 [2000] sq. ft. Avoid thoroughly wetting surfaces.

2. Point can towards surface and activate.

3. Using a sweeping motion, apply a light, uniform spray to all surfaces of furniture, carpets, rugs, drapes and around all pet resting areas. **IMPORTANT:** Only complete application to carpets, upholstery and other fabrics will ensure flea elimination. Note: Test in an inconspicuous place prior to use on light colored or delicate fabrics

4. For best results, eliminate fleas on your pet with (Brand Name) on-animal products.
