The amended labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable.

The alternate brand name: Gentrol® Point Source Roach Control Device has been added to the registration. Our records have been updated accordingly. This approval does not affect any terms or conditions that were previously imposed on this registration. You continue to be subject to existing terms or conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one (1) copy of the final printed labeling before you release this product for shipment with the new labeling. In accordance with 40 CFR § 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR § 152.3.

The label submitted with the application has been stamped "Accepted Only Indicated Revisions Reviewed" and is enclosed for your records.

Should you wish to add/retain a reference to your company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by EPA. DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

The active ingredient in this special roach [red or confused flour or merchant beetles (Stored Product Pests = SPP)] control product is GENTROL® [ZIGRONTM] insect growth regulator - a biorational insecticide similar to insect growth hormones that occur naturally in roaches [Stored Product Pests]. GENTROL is unique in that it controls roach [Stored Product Pests] populations by inhibiting reproduction and adult emergence. One to two weeks after application, you will begin to see roaches with crinkled wings, showing the initial effects of GENTROL. These roaches cannot reproduce. Because immature roaches are prevented from developing into reproductive adults, this product effectively breaks the roach life cycle. GENTROL prevents Stored Product Pests from becoming adults thus breaking the life cycle. By inhibiting reproduction and adult emergence, Zoecon® (S)-Hydroprene Roach Control Station II [device][unit][disk][Point Source], by itself, will control cockroach [Stored Product Pests] populations over time. For faster results, use Zoecon (S)-Hydroprene Roach Control Station II [device][unit][disk][Point Source] in conjunction with EPA approved products that kill adult roaches [Stored Product Pests]. Roach [Stored Product Pests] populations are difficult to control because roaches [Stored Product Pests] reproduce so rapidly. However, when a conventional insecticide designed to kill adult roaches [Stored Product Pests] does not provide 100% elimination, Zoecon (S)-Hydroprene Roach Control Station II [device][unit][disk][Point Source] works to prevent survivors from re-establishing the population.

Once GENTROL is released, the active ingredient moves from the [station][device][unit][disk][Point Source] into a localized area. Roaches [Stored Product Pests] do not have to come into contact with the [station][device][unit][disk][Point Source] to be affected.

Use Zoecon (S)-Hydroprene Roach Control Station II [device][unit][disk][Point Source] in buildings and modes of transportation. Permitted sites of application include [restaurants], homes, hotels, kitchens, laboratories, apartment buildings, day care centers, machinery, equipment, greenhouses, hospitals, mausoleums, nursing homes, office buildings, schools, and warehouses. Zoecon (S)-Hydroprene Roach Control Station II is also intended to be used in various modes of transportation including but not limited to, aircraft, buses, trucks, trailers, rail cars, and marine vessels.

FOOD HANDLING ESTABLISHMENTS

May be used in areas where food is handled or processed. Placements include areas for receiving, storage, packing, edible waste storage, machinery and enclosed processing systems (mills, dairies, edible oils, syrups). Serving areas would also be considered as a food area. Devices must not come into direct contact with any food preparation surfaces. Keep device a minimum distance of 3 feet from exposed food.

The Zoecon (S)-Hydroprene Roach Control Station II [device][unit][disk][Point Source] can also be used where conventional sprays and foggers are not appropriate or where baits are less effective due to competing food sources.

APPLICATION DIRECTIONS: Do not activate [station][device][unit][disk][Point Source] until ready to use. To activate the Zoecon (S)-Hydroprene Roach Control Station II [device][unit][disk][Point Source], press the pouch located on the side of the Zoecon (S)-Hydroprene Roach Control Station II [device][unit][disk][Point Source] firmly between thumb and forefinger until a snapping sound is heard indicating that the contents of the GENTROL capsule have been released. Following activation, the [station][device][unit][disk][Point Source] is now ready to apply. Place the [station][device][unit][disk][Point Source] in any orientation (vertical or horizontal). Do not place in areas accessible to children.

Place the [station][device][unit][disk][Point Source] in areas where roach [Stored Product Pests] activity has been observed. These areas include: in and around cabinets, closets, pantries, drawers, refuse areas, electrical boxes, equipment, and false ceilings. Also, place around doors, expansion joints, pipe chases, dressers, windows, heating and air conditioning ducts, refrigerators, and voids where pests are active.

Place 1 Zoecon (S)-Hydroprene Roach Control Station II [device][unit][disk][Point Source] to treat up to a 75 square foot area, paying particular attention to locations of roach [Stored Product Pests] activity. More [stations][devices][units][disks][Point Sources] may be needed in areas with a heavy roach [Stored Product Pests] infestation. For vertical placement, expose sticky surface by removing paper backing and pressing the [station][device][unit][disk][Point Source] firmly in place. In order for the Zoecon (S)-Hydroprene Roach Control Station II [device][unit][disk][Point Source] to adhere properly, wipe surface clean prior to application. Use as many tape strips per [station][device][unit][disk][Point Source] as needed. Replace all [stations][devices][units][disks][Point Sources] every 3 months for continued effectiveness.

Application Directions For Use With EPA-Registered Products Approved For Household Use Against Adult Roaches [Stored Product Pests]: Use the Zoecon (S)-Hydroprene Roach Control Station II [device][unit][disk][Point Source] alone or in conjunction with [Brand Name] roach baits. Place [Brand Name] roach product following use directions on the label. Place the Zoecon (S)-Hydroprene Roach Control Station II [device][unit][disk][Point Source] in close proximity to the [Brand Name] using 9 Zoecon (S)-Hydroprene Roach Control Station II's [devices][units][disks][Point Sources] per 675 square feet. By placing the Zoecon (S)-Hydroprene Roach Control Station II [device][unit][disk][Point Source] near the [Brand Name] product, young roaches that do not eat the bait will become affected by the GENTROL Insect Growth Regulator contained within the Zoecon (S)-Hydroprene Roach Control Station II [device][unit][disk][Point Source]. For best results, place the Zoecon (S)-Hydroprene Roach Control Station II [device][unit][disk][Point Source] in areas of roach [Stored Product Pests] activity.

Do not contaminate water, food, or feed by storage or disposal.

Storage: Store in a cool area away from children.
