- c. Delete claims of repellency for any pest i.e., "repels gnats, flies, mosquitoes." The Agency is currently in the process of formalizing policy relative to claims for repellency. The efficacy studies submitted in support of fleas and ticks, did not contain repellent data for the species noted. Due to the existence of other data in the Agency, the claims for lice may remain.



Continue to work lather in for 3 to 5 minutes (this is an important part of the grooming procedure), then rinse animal thoroughly. For extremely dirty or scaly animals, the above procedure may be repeated. Repeat every 7 to 10 days, if necessary, for adult flea relief. Flea egg hatch inhibition will last for 28 days. Do not use on puppies or kittens under 12 weeks.
