The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the above referenced product in connection with the Permethrin and Pyrethrins RED, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

NOTE: This product is **not** yet being reregistered under section 4(g) of FIFRA.

Please note that the record for this product currently contains the Confidential Statement of Formulation (CSF) listed below. Any previously dated CSFs are superseded.

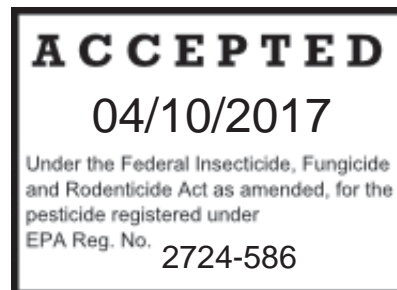

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

USE RESTRICTIONS:

DO NOT use on Kittens or Cats.

DO NOT use on puppies under 12 weeks of age.

DO NOT spray in face, eyes, or on genitalia.

For thin/short-haired dogs, to apply at the maximum rate, spray for 2 seconds for each lb of animal weight. For heavy/long-haired dogs, to apply at the maximum rate, spray for 8 seconds for each lb of animal weight.

USE INSTRUCTIONS:

HOLD CONTAINER UPRIGHT. SHAKE WELL BEFORE USING.

Spray dog from a distance of 8-12 inches. Start spraying at the tail, moving the dispenser rapidly and making sure the dog's entire body is covered, including the legs and under the body. Fluff the hair as you spray so the spray will penetrate to the skin. The spray should wet the ticks thoroughly. Apply at the rate of 2 seconds per pound of body weight for thin or short-haired dogs and up to 8 seconds per pound of body weight for heavy or long-haired dogs. Reapply after 2 weeks, if necessary. This product will kill fleas up to 14 days on dogs. It will kill ticks for 4 days on dogs.

Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals, or animals on medication. Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

STORAGE AND DISPOSAL
