The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the permethrin and tetramethrin Interim Decisions, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

ENVIRONMENTAL HAZARDS

This product is extremely toxic to aquatic organisms, including fish and invertebrates. Do not apply directly to or near water. DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

For both indoor and outdoor use.

USE RESTRICTIONS

Do not apply this product in a way that will contact adults, children, or pets, either directly or through drift.

Remove pets, birds and cover fish aquariums before spraying

Do not allow adults, children, or pets to enter or contact the treated area until sprays have dried. Do not allow adults, children, or pets to enter the treated area until aerosols have dispersed and the treated area has been thoroughly ventilated.

Do not remain in treated area, exit area immediately and remain outside the treated area until aerosols have dispersed.

Not for broadcast use on indoor residential surfaces.

Do not make application during rain. Avoid making applications when rainfall is expected before the product has sufficient time to dry (minimum 4 hours). Rainfall within 24 hours after application may cause unintended runoff of pesticide application.

Do not wet plants to point of runoff or drip.

Not for use in metered release systems or outdoor residential misting systems.

Application is prohibited directly into sewers or drains, or to any area like a gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur. Do not allow the produt to enter any drain during or after application.

Remove or cover exposed food and drinking water before application.

All outdoor applications must be limited to spot or crack and crevice treatments only, except for the following permitted uses:

- 1) Perimeter band treatments of 7 feet wide or less from the base of a man-made structure to pervious surfaces (e.g., soil, mulch, or lawn);
- 2) Application to pervious surfaces such as soil, lawn, turf, and other vegetation;
- 3) Applications to vertical surfaces (such as the side of a man-made structure) directly above impervious surfaces (e.g., driveways, sidewalks, etc.), up to 2 feet above ground level; Other than applications to building foundations, all outdoor applications to impervious surfaces such as sidewalks, driveways, patios, porches, and structural surfaces (such as windows, doors, and eaves) are limited to spot and crack and crevice applications only.

Spot treatments must not exceed two square feet in size (for example, 2ft. by 1 ft or 4 ft. by 0.5 ft.). Do not apply when the wind speed is greater than 15 mph.For soil or foliar applications, do not apply by ground within 25 feet of lakes, reservoirs, rivers, permanent streams, marshes or natural ponds, estuaries and commercial fish farm ponds.

Do not apply the product into fish pools, ponds, streams, or lakes. Do not apply directly to sewers or storm drains, or to any area like a drain or gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur.

Do not allow the product to enter any drain-during or after application.

Do not apply directly to impervious horizontal surfaces such as sidewalks, driveways, and patios except as a spot or crack-and-crevice treatment.

To apply at the maximum rate, spray for about 25 seconds to cover a space of 100 sq ft (10' x 10').

SHAKE WELL BEFORE USING INDOORS:

Remove protective cap, hold container upright and spray from a distance of 12 to 15 inches. Houseflies, Fruit Flies, Mosquitoes, Gnats, Wasps, Hornets, Bees, Black Flies, Skipper Flies, Blow Flies, and Small Flying Moths: Close all doors and windows. Spray 5-10 seconds for average room especially windows and other light sources which attract these insects. Keep nozzle in constant motion. Keep room closed for 15 minutes after spraying. Sweep up and discard fallen insects. Repeat treatment as necessary.

Cockroaches, Waterbugs, Palmetto Bugs, Silverfish, Firebrats, Crickets, Scorpions, Spiders, Millipedes, Centipedes, Sowbugs and Pillbugs: Spray into hiding places such as cracks and crevices, behind sinks, cabinets, along baseboards and floors, around drains and plumbing, hitting insects with spray whenever possible. Repeat treatment as necessary.

Ants: Spray trails, nests and points of entry. Spray on ants where possible. Repeat as necessary. Carpet Beetles: Spray directly on beetles, floors, baseboards, shelves and carpets. Repeat treatment as necessary.

Bedbugs: Spray mattresses, particularly around tufts and seams. Take beds apart and spray into all joints. Treat baseboards, moldings and floor. Repeat treatment as necessary. To Control Clothes Moths and Carpet Beetles on wool and other proteinaceous fibers: Remove infested articles from storage, brush thoroughly, and air for several hours in sunlight, if possible. Apply spray liberally to empty chests, closets, bureaus and other storages directing the spray into cracks, joints and crevices. After airing, infested articles may be treated by spraying lightly, keeping nozzle at least three feet from fabric to avoid staining.

OUTDOORS:

Point spray nozzle away from face. Hold can on slight downward angle. For best results, spray when air is calm. Allow a few minutes for product to take effect. Spray with wind if breeze is blowing.

Pests on Outside Surfaces of Buildings: For control of building infestation due to Ants, Clover Mites, Crickets, Earwigs, Millipedes, and Sowbugs (Pillbugs). Spray foundation of building where insects are active and may find entrance, up to a height of 2 to 3 feet. Apply as a residual spray to outside surface of buildings where insects tend to congregate. Spray areas include (but are not limited to) screens, window frames, eaves, porches, patios, garages and refuse dumps. Repeat treatment as necessary.

FLYING INSECTS: Flies, Mosquitoes, Gnats, Small Flying Moths, Hornets and Yellow Jackets. Allow fog to drift over area. Direct spray toward bushes, or grass from at least 4 to 6 feet away. Give special attention to breeding areas such as garbage cans and compost piles. Repeat as necessary.

CRAWLING INSECTS: Ants, Cockroaches, including Asian Cockroaches, Crickets, Mole Crickets, Centipedes, and Silverfish. Spray infested surface of patio or picnic area, hitting as many insects as possible. Also spray legs of tables and chairs to repel ants. Spray ant trails and hills. Ants, Lone Star Ticks, Crickets, Fleas and Earwigs: Apply thoroughly to infestations in bushes, grass or weeds. For Ants, spray freely around ant trails and hills. For Control of Ornamental Garden Insects: For use on roses, dahlias, asters and other ornamentals to kill Japanese Beetles hit by spray, as well as Whiteflies, Aphids, exposed Thrips, Spiders, Red Mites and Leafminers.

ORNAMENTAL PLANTS:

May be used on plants, as well as a multi-purpose spray in small gardens and for spot treatments of incipient insect infestations to prevent spreading in large garden areas. May also be used on other plants such as African Violets, asters, azaleas, begonias, camellias, carnations, chrysanthemums, dahlias, geraniums, crassula, grape vine, Kentia palm, laurel, marigolds, rhododendrons, roses, rubber plants, snapdragons, stocks, wandering Jews and zinnias. Effective when used as directed against Whiteflies, Aphids, Spider and Red Mites, exposed Thrips, Lace Bugs, Japanese Beetles, Pavement Ants, Clover Mites and Army Worms. When spraying plants, do not operate closer than 18 inches. Use sweeping motion. Spray in one second bursts. Be cautious about wetting tender foliage, young plants and new growth. Do not spray plants when temperatures exceed 90° F. Contact insects directly whenever possible. Repeat treatment as infestations occur.

STORAGE AND DISPOSAL

PESTICIDE STORAGE: Store in a cool, dry area. Do not transport or store below 32° F. **CONTAINER HANDLING AND DISPOSAL:** Do Not Puncture or Incinerate! **If empty:** Place in trash or offer for recycling if available. **If partly filled:** Do not pour or dispose down-the-drain or sewer.
