The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the above referenced product in connection with the tetramethrin, permethrin and piperonyl butoxide (PBO) REDs, and has concluded that your submission is acceptable.

NOTE: This product is not being reregistered under sections 3(c)5 and 4(g) of FIFRA at this time.

Please note that the record for this product currently contains the Confidential Statements of Formulation (CSFs) listed below. Any previously dated CSFs are superseded.

ENVIRONMENTAL HAZARDS

This product is extremely toxic to aquatic organisms, including fish and invertebrates. Do not apply directly to or near water. This pesticide is highly toxic to bees exposed to direct treatment on blooming crops or weeds. It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

USE RESTRICTIONS:

Do not allow adults, children, or pets to enter the treated area until sprays have dried or dispersed, and the treated indoor area has been thoroughly ventilated:

Do not make applications during rain.

Do not wet treated area to point of runoff or drip.

Do not use treated article until spray has dried.

Remove or cover exposed food and drinking water before application.

Remove or cover dishes, utensils, food processing equipment, and food preparation surfaces, or wash them before use.

All outdoor applications must be limited to spot or crack and crevice treatments only, except for the following permitted uses: 1) Treatment to soil or vegetation around structures; 2) Applications to lawns, turf, and other vegetation; 3) Applications to building foundations, up to a maximum height of 3 feet. Other than applications to building foundations, all outdoor applications to impervious surfaces such as sidewalks, driveways, patios, porches, and structural surfaces (such as windows, doors, and eaves) are limited to spot and crack and crevice applications only.

Do not water the treated area to the point of runoff.

To apply at the maximum rate, spray for about 2 seconds to cover a space of 1 square foot.

This product can be used both indoors (attics, windows, doors, eaves, where nests are built), and outdoors on wasp and hornet nests.

INDOORS

Do not apply this product in a way that will contact adults, children, or pets, either directly or through drift. Remove pets, birds, and cover fish aquariums before spraying. Do not apply when food is present. To operate, remove protective cap and depress button, being sure to aim spray opening at the location to be sprayed. Not for broadcast use on indoor residential surfaces. Direct at wasps, hornets and yellow jackets whenever possible, and under eaves, into nests, cracks, holes or crevices wherever insects are noticed. Spray for about 1-2 seconds or until surface is moist from insecticide. To prevent entrance of insects into the house, spray around points where outside plumbing, faucets, etc. enter the house and into cracks or crevices in foundation as well as along sills and ledges. Do not use this product on or near asphalt shingles or vinyl siding due to the possibility of staining.

OUTDOORS

Kills Wasps, Hornets and Yellow Jackets: This spray is fast acting when insects are hit directly. With the breeze at your back, thoroughly spray the nest until it is soaked. Allow about 24 hours for those insects which were not directly hit by spray to leave the area. If insects should return to the treated area, spray again. This container delivers a stream type spray, making it possible for the operator to stay back from the places sprayed. This formula utilizes Synergist Piperonyl Butoxide, Permethrin, and Tetramethrin, a combination* specifically effective on this class of insects. It is preferable to apply this product in the evening after all the insects have returned to the nest and are at rest.
