
The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the permethrin and tetramethrin Interim Decisions, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance Assurance.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling and must be used at your next label printing. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 12 months from the date of this letter. After 12 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

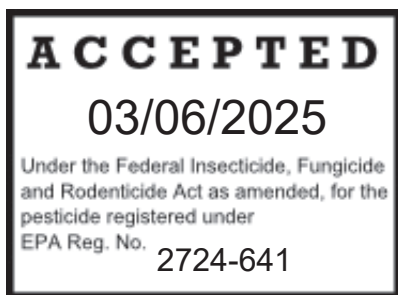

ENVIRONMENTAL HAZARDS

This product is extremely toxic to aquatic organisms, including fish and invertebrates. Do not apply directly to or near water. To protect the environment, do not allow pesticide to enter or runoff into storm drains, drainage ditches, gutters, or surface waters. Applying this product in calm weather when rain is not predicted for the next 24 hours will help to ensure that wind or rain does not blow or wash pesticide off the treatment area. See Directions for Use for additional precautions and requirements. This pesticide is highly toxic to bees exposed to direct treatment on blooming crops or weeds. Do not apply this product or allow it to drift to blooming crops or weeds while bees are visiting the treatment area.

PHYSICAL OR CHEMICAL HAZARDS

Extremely flammable. Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 130° F may cause bursting.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

For both indoor and outdoor use.

PRECAUTIONS AND RESTRICTIONS:

Remove pets, birds, and cover fish aquariums before spraying.

Do not apply this product in a way that will contact adults, children, or pets, either directly or through drift.

Do not allow adults, children, or pets to enter the treated area until sprays have dried or dispersed, and the treated indoor area has been thoroughly ventilated.

Not for broadcast use on indoor residential surfaces.

Do not wet treated area to point of runoff or drip.

Do not use treated article until spray has dried.

Do not apply when food is present. Remove or cover exposed food. Cover food preparation surfaces and utensils during treatment, or wash thoroughly before use.

Application is prohibited directly into sewers or drains, or to any area like a gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur. Do not allow the product to enter any drain during or after application.

Do not allow to enter any indoor or outdoor drains. (No permita la entrada a desagües internos o

All outdoor spray applications must be limited to spot or crack and crevice treatments only, except for the following permitted uses:

1. Application to pervious surfaces such as soil, lawn, turf or other vegetation ;
2. Perimeter band treatments of 7 feet wide or less from the base of a man-made structure to pervious surfaces (e.g., soil, mulch, or lawn);
3. Applications to underside of eaves, soffits, doors, or windows permanently protected from rainfall by a covering, overhang, awning, or other structure;
4. Applications around potential exterior pest entry points into man-made structures such as doorways and windows, when limited to a band not to exceed one inch;
5. Applications to vertical surfaces (such as the side of a manmade structure) directly above impervious surfaces (e.g., driveways, sidewalks, etc.), up to 2 feet above ground level.
6. Applications to vertical surfaces directly above pervious surfaces, such as soil, lawn, turf, mulch or other vegetation) only if the pervious surface does not drain into ditches, storm drains, gutters, or surface waters.

Spot treatments must not exceed two square feet in size (for example, 2 ft. by 1 ft. or 4 ft. by 0.5 ft.).

For soil or foliar applications, do not apply by ground within 25 feet of lakes, reservoirs, rivers, permanent streams, marshes or natural ponds, estuaries and commercial fish farm ponds.

Do not apply the product into fish pools, ponds, streams, or lakes. Do not apply directly to sewers or storm drains, or to any area like a drain or gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur.

Do not apply directly to impervious horizontal surfaces such as sidewalks, driveways, and patios except as a spot or crack-and-crevice treatment.

Do not apply or irrigate to the point of runoff.

Treat surfaces to ensure thorough coverage but avoid runoff.

To treat insects harbored in voids and cracks-and-crevices, applications must be made in such a manner to limit dripping and avoid runoff onto untreated structural surfaces and plants.

Do not water the treated area to the point of runoff.

Do not make applications during rain.

Avoid making applications when rainfall is expected before the product has sufficient time to dry (minimum 4 hours). Rainfall within 24 hours after application may cause unintended runoff of pesticide application.

This product can be used both indoors (attics and other places where nests are built), and outdoors on wasp and hornet nests.

To operate, remove protective cap and depress button, being sure to aim spray opening at the location to be sprayed. To apply at the maximum rate, spray for about 2 seconds to cover a space of 1 sq ft. Direct at wasps, hornets and yellow jackets whenever possible and under eaves, into nests, cracks, holes or crevices wherever insects are noticed. Spray for about 1-2 seconds or until surface is moist from insecticide. To prevent entrance of insects into the house, spray around points where outside plumbing, faucets, etc. enter the house and into cracks or crevices in foundation as well as along sills and ledges.

Kills Wasps, Hornets and Yellow Jackets: This spray is fast acting when insects are hit directly. With the breeze at your back, thoroughly spray the nest until it is soaked. Allow about 24 hours for those insects which were not directly hit by spray to leave the area. If insects should return to the treated area, spray again. This container delivers a stream type spray, making it possible for the operator to stay back from the places sprayed. This formula utilizes synergist Piperonyl Butoxide, Permethrin and Tetramethrin, a combination specifically effective on this class of insects. It is preferable to apply this product in the evening after all the insects have returned to the nest and are at rest.

STORAGE AND DISPOSAL

PESTICIDE STORAGE: Do not store near heat or open flame. Store in cool, dry area away from children. **PESTICIDE DISPOSAL AND CONTAINER HANDLING:** Do Not Puncture or Incinerate! **If empty:** Place in trash or offer for recycling if available. **If partly filled:** Do not dispose of down-the-drain or sewer. Call your local solid waste agency for local disposal options.
