The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable with the following label revision provision(s):

Precautionary Statements, Hazards to Humans and Domestic Animals subsection comment(s), top of page 2 of 5:

 Insert the following text immediately preceding the existing 1<sup>st</sup> sentence within this subsection: "Harmful if swallowed."

Precautionary Statements, First Aid subsection comment(s), middle of page 2 of 5:

 Revise the 2<sup>nd</sup> sentence of the HOT LINE NUMBER statement to read "For additional information on this product (including health concerns, medical emergencies or pesticide incidents), you may call 1-800-xxx-xxxx, twenty-four (24) hours per day, seven (7) days per week."

Directions for Use, USE RESTRICTIONS subsection comment(s), bottom of page 3 of 5:

3. Within the 9<sup>th</sup> bulleted statement, capitalize the letter "o" at the beginning of the 2<sup>nd</sup> sentence.

Storage and Disposal Statement section comment(s), page 5 of 5:

4. Revise the "DISPOSAL:" subsection heading to read "CONTAINER DISPOSAL:"

#### INDOORS

Hold container upright with nozzle away from you. Press valve down and spray surface until slightly wet (at a rate of 2 seconds to treat approximately 1 linear foot of baseboard area).

Bed Bugs – Thoroughly inspect area of suspected bed bug infestation and note potential harborage sites or actual infestations.
