SECURITY BT DUST BIOLOGICAL INSECTICIDE is a biological insecticide intended for use against chewing larvae (caterpillars) of certain lepidopterous species. Apply SECURITY BT DUST BIOLOGICAL INSECTICIDE when pests are first noticed and repeat as necessary. Thorough plant coverage is necessary for control.

BROCCOLI, CABBAGE, CAULIFLOWER, COLLARDS, KALE, MUSTARD GREENS, TRUNIP GREENS: To control Cabbage Looper and Imported Cabbage Worm, apply 2 to 3 ounces per 50 foot of row.

CELERY, LETTUCE, MELONS, POTATOES, SPINACH, TOMATOES, CUCUMBERS: To control Cabbage Looper, apply 2 to 3 ounces per 50 foot of row.

TOBACCO AND TOMATOES: To control Hornworm, apply 1 to 2 ounces per 50 foot of row.

STORAGE AND DISPOSAL

Pesticide Storage: Store in a cool, dry place inaccessible to children and pets.

Pesticide Disposal and Container Handling: **If empty:** Non-refillable container. Do not reuse or refill this container. Place in trash or offer for recycling if available. **If partially filled:** Call your local solid waste agency for disposal instructions.
