Apply directly to exposed insects - roaches, ants, spiders, crickets, waterbugs, silverfish, sowbugs, and carpet beetles: Spray areas where these pests are found or may hide, including dark corners of rooms and closets, cracks and crevices, along baseboards and door sills and frames, behind sinks, stoves, refrigerators, and cabinets and around garbage cans, plumbing and other utility installations. Directly spray pests driven out of hiding places. Spray ant trails, nests and points of entry. Repeat as necessary.

On Pet Bedding: Treat pet bedding and resting places. Apply a uniform application of ETOFENPROX IGR HOME & CARPET SPRAY II to nearby cracks and crevices, along and behind baseboards, window and door sills, and localized areas of floors where fleas or ticks may be present as these are primary hiding places for fleas. Pet bedding does not need to be removed after treatment.
