The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Etofenprox, Prallethrin, and Pyriproxyfen Interim Decisions, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. Do not apply this product in a way that will contact adults, children, or pets, either directly or through drift. Remove pets, birds, and cover fish aquariums before spraying.

Do not allow adults, children, or pets to enter the treated area until sprays have dried.

Do not wet articles to point of runoff or drip. Do not use treated article until spray has dried.

Remove or cover exposed food and drinking water before application.

Remove or cover dishes, utensils, food processing equipment, and food preparation surfaces, or wash them before use.

Do not apply directly into sewers or drains, or to any area like a gutter where drainage to storm sewers, water bodies, or aquatic habitat can occur. Do not allow the product to enter any drain during or after application.

To apply at the maximum rate, spray for 3 seconds to cover a 3 ft X 3 ft area. Do not apply as a broad carpet treatment. Only spots less than 3 feet by 3 feet per room may be applied with this product.

Indoors: Thoroughly vacuum all carpeting, upholstered furniture, along baseboards, under furniture and in closets. Seal vacuum bag and dispose of in trash outdoors. Spray ETOFENPROX IGR HOME & CARPET SPRAY II from 2 feet to 3 feet away from surface being treated. Apply with a smooth back-and-forth motion to carpets, drapes, rugs, and upholstered furniture. A fine mist spray that is evenly applied will do the job properly. Do not spray wood furniture, floors or trim as water spotting may occur. Repeat treatment every 14 days to control adult fleas and ticks.

Apply directly to exposed insects - roaches, ants, spiders, crickets, waterbugs, silverfish, sowbugs, and carpet beetles: Spray areas where these pests are found or may hide, including dark corners of rooms and closets, cracks and crevices, along baseboards and door sills and frames, behind sinks, stoves, refrigerators, and cabinets and around garbage cans, plumbing and other utility installations. Directly spray pests driven out of hiding places. Spray ant trails, nests and points of entry. Repeat treatment every 14 days.

On Pet Bedding: Treat pet bedding and resting places. Apply a uniform application of ETOFENPROX IGR HOME & CARPET SPRAY II to nearby cracks and crevices, along and behind baseboards, window and door sills, and localized areas of floors where fleas or ticks may be present as these are primary hiding places for fleas. Pet bedding does not need to be removed after treatment.

Indoor Kennels:

Remove pets before spraying.

Spray ETOFENPROX IGR HOME & CARPET SPRAY II from 2 feet to 3 feet away from surface being treated. Apply with a smooth back-and-forth motion. A fine mist spray that is evenly applied will do the job properly.

Repeat treatments to infested areas as necessary at intervals of 14 days or greater. Do not make more than 6 applications per site per year.

STORAGE AND DISPOSAL

Do not contaminate water food or feed by storage or disposal.

PESTICIDE STORAGE: Do not store near heat or open flame. Store in cool dry area away from children.
