2. Make the following change(s) to the label:

- a. Change the product registration number to "EPA Reg. No. 2724-792"
- b. Make the following label revisions:

Optional Marketing Claims section comment(s):

1. On the 1st optional marketing claim, replace the word "carry" with the word "transmit" and replace the word "on" with the word "through."
2. Delete the 2nd optional marketing claim since it is broad, ambiguous and therefore false and misleading.
3. On the 3rd optional marketing claim, delete the words "[Specially formulated]" since these words imply heightened efficacy. In addition, insert the words "over 12 weeks of age" immediately following the word "puppies."
4. Delete the 4th, 6th and 14th optional marketing claims since they imply heightened efficacy.
5. Delete the 5th optional marketing claim since these statements contradict the Directions for Use.
6. Delete the 10th, 11th, 12th and 13th optional marketing claims since they are implied safety claims.

Directions for Use section comment(s):

7. As required by the REDs for pyrethrins and piperonyl butoxide, add the following new subsection immediately following the statement "It is a violation of..." This information must be placed in a text box as follows:

8. Revise the 7th sentence in this section with: "Do not apply more than once per week for the control of adult fleas and ticks."
9. Add the following text at the end of this Directions for Use: "Animal bedding/quarters should be treated with an approved product labeled for that use at the same time that [animal][pet][dog/cat/puppy/kitten] is treated with [Brand Name]."

Precautionary Statements, Hazards to Humans and Domestic Animals section comment(s):

- 10. Replace the existing 4th sentence in the **HUMANS** subsection with: "Wash hands thoroughly with plenty of soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet."
- 11. Delete the 2nd paragraph starting with "**ANIMALS:**" since this text has been moved to the new "**General Precautions and Use Restrictions**" subsection listed/added in Item #9.

Storage and Disposal section comment(s):

- 12. Place the Storage and Disposal Statement within a solid text box to increase its prominence. Within the text box, the Storage and Disposal heading should be placed on the top and in a central position above the Storage and Disposal Statement. Replace this section with:

- 13. Within one (1) year from the date of this registration, Wellmark International is obligated to submit a One Year Storage Stability (830.6317) study and a Corrosion Characteristics (830.6320) study on this product in support of this registration.¹
 - 14. Within forty-five (45) days from the date of this letter, Wellmark International should submit a label amendment revising the "Warranty & Disclaimer" section in accordance with the guidance document entitled, "Guidance on Warranty Statements" and dated October 17, 2006. This update can be found at the following hyperlink: <http://www.epa.gov/pesticides/regulating/labels/warranty.pdf>. When resubmitting, the subtitle "Warranty & Disclaimer" should be added to clarify the intent of the language contained within.
 - 15. Delete the reference to the "[web site URL]" currently found at the bottom of page 3. This reference is considered collateral labeling.
3. You must submit two (2) copies of the revised final printed labeling, incorporating the above changes, before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes accepting of these conditions.

Wellmark International should note that a notice of availability of EPA's reregistration eligibility decision (RED) document for products containing pyrethrins was published in the *Federal Register* on July 26, 2006 (Volume 71, Number 143, Pages 42387-42389). In addition, EPA's RED for products containing piperonyl butoxide was published in the *Federal Register* on July 26, 2006 (Volume 71, Number 143, Pages 42385-42386). As a result, additional data and/or labeling changes may be required for products containing pyrethrins and/or piperonyl butoxide.
