Enclosed is completed EPA Form 8570-1 and 2 copies of highlighted revised labeling for the above product (red is new text, blue strikethrough is deleted text). This represents notification of alternate brand name: ZODIAC® OASIS® Flea & Tick Shampoo for Dogs. Additionally, two sentences in the Directions for Use were rephrased/joined to clarify that the application rate of 1½ tablespoons per 5 lbs of pet body weight represents an amount to be used on entire pet (no change in rate).

Label comments from the June 17, 2008 EPA letter (copy attached) have been incorporated as well. All changes were made with the exception of: Point #3 advised us to delete our web site URL. I believe at this time, EPA is allowing website URL's to appear on labels (did not delete). Points 14 and 15 – First Aid: Per an August 5, 2008 telephone conversation with Carmen Rodia, he agreed that those points did not need to be revised and the label text could remain as it was submitted.

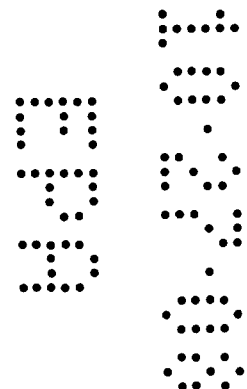

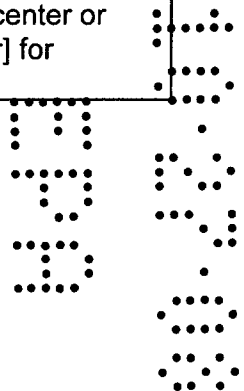
