The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the above referenced product in connection with Pyrethrins Reregistration Eligibility Document (RED), and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

NOTE: This product is **not** being reregistered under section 4(g) of FIFRA at this time.

Should you wish to retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. - The maximum application rate is once per week.

After lather has been worked in over the entire pet [animal][dog/cat/puppy/kitten], rinse [animal][pet][cat/dog/puppy/kitten] thoroughly with warm water. For extremely dirty or scaly animals [pets][cat/dog/puppy/kitten], the above procedure may be immediately repeated. Do not apply more than once per week for control of adult fleas and ticks. Treat animal bedding/quarters with an approved product labeled for that use at the same time that [pet][dog/cat/puppy/kitten] is treated with [Brand Name].
