Add the RF2222 CCG last, and mix thoroughly.

This manufacturing use product may be used to make EPA-registered premixes and supplements containing (S)-Methoprene, such as 0.4% (S)-Methoprene premix (EPA Reg. No. 2724-474) and supplements ranging between 0.02 and 0.0025% (S)-Methoprene. For finished cattle feeds/supplements, blend the manufacturing use product at a rate of no more than 20 pounds of this product per ton of cattle feed/supplement, to remain below the 150 ppm maximum limit established for ethoxyquin by FDA.

It is the responsibility of the manufacturer or formulator of the EPA-registered cattle feed-through product to ensure that any feed ingredients used in the formulation of the feed-through product containing this manufacturing use product comply fully with applicable FDA requirements for cattle feeds.

STORAGE AND DISPOSAL: Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Store in a cool, dry place.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.
