PRECAUTIONS

3. MCPP-4K IS ACTIVE AT LOW CONCENTRATIONS. DO NOT SPRAY IN WINDY WEATHER AS THE SPRAY DRIFT MAY CAUSE DAMAGE TO NEIGHBORING CROPS. AVOID SPRAY DRIFT TO SUSCEPTIBLE PLANTS AS THIS PRODUCT MAY INJURE BEANS, TOMATOES, PEAS, COTTON, GRAPES, ORNAMENTALS.
4. PONDS, STREAMS, RIVERS AND WATER COURSES MUST NOT BE CONTAMINATED WITH THE CONCENTRATE, SPRAY OR WASHINGS.
5. WASH EQUIPMENT THOROUGHLY WITH WATER AND A WETTING AGENT, LIQUID DETERGENT, OR WITH A SUITABLE CHEMICAL CLEANER BEFORE USING FOR OTHER PURPOSES.
