CORN (at planting time) — For control of corn rootworms: Use 4 to 6.5 lbs. per acre (40 inch row spacing) or 4 to 8 ozs. per 1000 feet of row (for any row spacing). Apply RAMPART 15-G in a 7 inch band over the row directly behind the planter shoe in front of the press wheel. Do not place RAMPART 15-G in direct contact with seed. Use the 6.5 lb. rate in areas having high rootworm populations.

CORN (post-emergence) — For control of corn rootworms: Use 4 to 6.5 lbs. per acre (40 inch row spacing) or 4 to 8 ozs. per 1000 feet of row (for any row spacing).
