## **DIRECTIONS FOR USE:**

- (A) THOROUGHLY MIX ONE PART (BY WEIGHT) OF RODENTICIDE WITH NINETEEN PARTS OF DRY CEREAL BAIT.
- (B) PLACE BAIT IN LOCATIONS WHERE RATS AND MICE FEED, WATER OR TRAVEL.
- (C) BAIT PLACEMENTS ALONG WALLS, IN CORNERS, AND IN CONCEAL ED LOCATIONS WHERE RATS AND MICE FEED ARE DESIRABLE.
- (D) BAITS SHOULD BE PLACED IN AREAS INACCESSIBLE TO CHILDREN, PETS, AND DOMESTIC ANIMALS, OR IN TAMPER PROOF BAIT BOXES.

## FOR RAT CONTROL:

- (A) PLACE AT LEAST FOUR OUNCES OF BAIT AT EACH BAIT LOCATION
- (B) MAINTAIN AN UNINTERRUPTED SUPPLY OF BAIT IN THE STATIONS FOR APPROXIMATELY 10 DAYS.

## FOR MOUSE CONTROL:

- (A) PLACE TABLESPOON AMOUNTS OF BAIT AT 8 -17) FEET INTERVALS
- (B) MAINTAIN AN UNINTERRUPTED SUPPLY OF BAIT FOR AT LEAST 15 DAYS.

NOTE: IF BAIT MOLDS DECOMPOSES OR BECOMES SOUR, REPLACE WITH FRESH MATERIALS
