DIRECTIONS FOR USE

Captan 25 Seed Protectant is especially formulated for treatment of seed for the control of seed and soil-borne diseases, including damping-off, seed decay organisms, and seedling blights, and is prepared for use directly in the planter or drill box.

The amount of seed protectant, as shown in the recommendations, should be poured over the seed in the planter or drill box and stirred with the seed for uniform distribution throughout the hopper. The amounts recommended will provide adequate coverage of the seed and any excess, that does not adhere to the seed coat, will flow with the seed into the furrow, giving additional protection against soil-borne diseases. May be used on previously treated seed.

Do not use treated seed for feed, food or oil purposes.

RECOMMENDATIONS

SOYBEANS: Use Captan 25 Seed Protectant at the rate of 4 oz. per bu., or 7 oz. per 100 lbs. of seed as a planter box treatment.

PEANUTS (Shelled): For the control of Aspergillus Niger and other seed and soil-borne diseases, use 2 to 4 oz. Captan 25 Seed Protectant per bushel, or 4 to 6 oz. per 100 lbs. of seed as a planter box treatment.

WHEAT: Use Captan 25 Seed Protectant at the rate of 3 oz. per bu., or 4½ oz. per 100 lbs. of seed as a drill box treatment. This treatment is not recommended for the control of bunt (smut).
