- f. Under Storage and Disposal, move the text "Do not store under conditions which might...and penetration of moisture." to the Pesticide Storage section.
- g. Under Container Disposal, include the appropriate residue removal instructions by formulation and container type, in accordance with PR Notice 2007-4.
- h. Change the Container Disposal text from "Offer for recycling, if available." to "Then offer for recycling if available, or puncture and dispose of in a sanitary landfill or by incineration. Do not burn unless allowed by state and local ordinances."
