Terrestrial Non-Food Uses:

- Commercial greenhouses and nurseries;
- Ornamental seed crops (flowers, bulbs. Etc. except in the state of California;
- Landscape, industrial, recreational, commercial, residential and public areas;
- Turf renovation (all turf areas except commercial sod farms);
- Dormant established non-feed/non-crop bermudagrass, zoysiagrass turfgrass;
- Non-crop or Non-planted Areas on Farms including: Fence Lines, and Dry (non-flooded) Areas around ponds, lakes, and drainage ditches;
- Rights-of-way including: Railroads, Highways, Roads, Dividers and Medians, Pipelines, Public Utility Lines, Pumping Stations, Transformer Stations and Substations;
- Around Electrical Utilities, Commercial Buildings, Manufacturing Plants, Storage Yards, Rail Yards, Non-agricultural Fence Lines and Parkway. [FOR LARGE PLASTIC CONTAINERS greater than 5 gallons] Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ½ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Empty the rinsate into the application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. **Pressure rinse as follows**: Empty the remaining contents into application equipment or a mix tank and drain container for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. [FOR BULK AND MINIBULK PLASTICS CONTAINERS]

Agitate vigorously or recirculate water with the pump for 2 minutes. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this rinsing procedure two times.
