The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below.

- 1. A section entitled "Hazards to Humans and Domestic Animals" should be inserted directly under the general heading "Precautionary Statements." This section is required indicating the particular hazard, the route(s) of exposure and the precautions to be taken to avoid accident, injury or damage. The precautionary paragraph shall be immediately preceded by the appropriate hazard signal word. Since Onex has been classified as toxicity category III, the following appropriate statement(s) should be modified or expanded to reflect specific hazards and inserted within the heading "Hazards to Humans and Domestic Animals."
 - a. If there are oral, inhalation or dermal toxicity category III routes of exposure then the following appropriate statement must be inserted:

"Harmful if swallowed [inhaled or absorbed through the skin]. Avoid breathing vapors [dust or spray mist]. Avoid contact with skin [eyes or clothing]. [Appropriate first aid statement required].

b. If there are localized skin and eye toxicity category III routes of exposure, then the following statement must be inserted:

"Avoid contact with skin, eyes or clothing. In case of contact immediately flush eyes or skin with plenty of water. Get medical attention if irritation persists."

c. All other existing precautionary information must also be appropriately listed on the label.
