In the Precautionary Statements, in the list of restrictions, delete "Do not use other pesticides or drugs on dogs while collar is worn" and replace with "Do not use this product on animals simultaneously or within 30 days before or after treatment with or exposure to cholinesterase inhibiting drugs, pesticides or chemicals. However, the collar may be immediately replaced."




