Dear Mr. Exum:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

- 1) Please place your signal word "CAUTION" in bold, all caps directly below the words "Hazards to Humans and Domestic Animals".
- 2) If your product has certain precautions or incidents associated with it, please follow your "USE ONLY ON DOGS AND CATS" statement with the specific breeds that your product should <u>not</u> be used on: "Do not use on...(specific breed)"

- 3) In your "Hazards to Humans and Domestic Animals" statement, please add the word "medicated" to the sentence "Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals."
- 4) Please include your complete address (including the street) on the label.

 Additionally, please provide your company telephone number or number of
 Animal Poison Control Center that consumers may call for questions or in the
 event of an emergency.
- Please delete the statement "Repeat as needed" from your Directions for Use.

 Please state the minimum allowable interval between applications. This should be based on your efficacy data.

In response to your May 12, 1998 letter your request for a waiver of efficacy data is denied. Although we agree that this type of mange mite is not of public health significance, that does not justify a waiver of efficacy data. A registrant is required to have appropriate efficacy data to support all claims on the label. If the pest is of public health significance then the data must be submitted and reviewed as a prerequisite to approval. As stated in our last letter our records do not indicate this type of product is registered for control of sarcoptic mange mites.

We regret that we did not respond to your final printed label submission and are thankful that you reminded us. By looking at your label one final time we were able to clear up remaining inconsistencies. DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its lebeling. HOLD CONTAINER UPRIGHT, SHAKE WELL BEFORE USING. HOLD CONTAINER UPRIGHT, SHAKE WELL BEFORE USING.
This product will kill flees up to 14 days on dops and cats and will kill licks for 4 days on dops and 9 days on cats.
Spray animal from a distance of 8-12 inches, Sart spraying at the tail, moving the depender rapidly and making sure the arima's artife body is covered, including large and under the body. Full the hair as you apray so the spray will penetrate to the skin. The spray should wat the ticks thoroughly. Repeat as needed.
For cats apply at the rate of 1 second per pound of body weight. For dogs apply at the rate of 2 seconds per pound of body weight for this or anorthwared dogs and up to 8 seconds per pound of body weight for heavy or lang-haired dogs. For information call 1-800-326-5225
