The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Permethrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance Assurance.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling and must be used at your next label printing. You must submit one copy of the final printed labeling before you release the product for

"To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

HOLD CONTAINER UPRIGHT, SHAKE WELL BEFORE USING For indoor use only.

This product will kill fleas up to 14 days on dogs and cats, and will kill ticks for 4 days on dogs and 9 days on cats.

Application of product on pets must only be done indoors. Spray animal at a distance of 8 – 12 inches. Start spraying at the tail, moving the dispenser rapidly and making sure the animal's entire body is covered, including legs and underbody. Fluff the hair as you spray so the spray will penetrate to the skin. The spray should wet the ticks thoroughly.

For cats apply at the rate of 1 second per pound of body weight. For dogs, apply at the rate of 2 seconds per pound of body weight for thin and short haired dogs and up to 8 seconds per pound of body weight for heavy and long haired dogs. For information, call 1-800-326-5225.
