Dear Dr. Weatherston,

The Agency is in receipt of your Application for Pesticide Notification under Pesticide Registration Notices (PRNs) 2007-1 and 2007-4 dated August 29, 2008 for the product Sardex II[®] (EPA Registration Number 2781-51). The Registration Division (RD) has conducted its review of this request for its applicability under PRNs 2007-1 and 2007-4 and finds that the label changes requested fall within the scope of PRNs 2007-1 and 2007-4. The label submitted with the application has been stamped "Notification" and will be placed in our records. Please note that the word "incinerate" on the proposed label is misspelled, and this should be corrected on the final printed label.

Please be reminded that 40 CFR Part 156.140(a)(4) requires that a batch code, lot number, or other code identifying the batch of the pesticide distributed and sold be placed on nonrefillable containers. The code may appear either on the label (and can be added by non-notification/PR Notice 98-10) or durably marked on the container itself.


