## **DIRECTION FOR USE:**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

#### FOR USE ON CITRUS:

Dilute one gallon of Deccosol 122 Concentrate with 40 to 72 gallons of water for use in citrus wash tank at a concentration ranging from 0.2 to 0.35% sodium orthophenylphenate (anhydrous). Caustic soda should be added, when necessary, to maintain the pH in the wash tank above 11.6. The citrus should not be in the wash tank for more than 5 minutes and must be rinsed thoroughly with fresh water upon leaving the tank.

### SANITATION OF PRODUCE PICKING CONTAINERS:

Dilute one gallon of Deccosol 122 with 69 gallons of water to give a treating concentration of 0.21% sodium orthophenylphenate (anhydrous). This can be applied by brushing, dipping or spraying. Do not rinse. Do not put produce in sanitized picking container until the container is completely dry.

#### IN CITRUS BIN DRENCHERS (CALIFORNIA ONLY):

When filling the drencher, add one gallon of Deccosol 122 to 413 gallons of water to give a treating concentration of 0.035% (350 ppm) of sodium orthophenylphenate (anhydrous). Do not use over 500 ppm (1 gallon of Deccosol 122 to 289 gallons of water) to avoid injury to citrus. During operation of bin drencher add 1 gallon of Deccosol 122 to 413 gallons of make-up water to maintain treating concentration of 350 ppm. While bins are being drenched, increase the feed rate of the Deccosol 122 pump slightly to maintain the 350 ppm treatment level.

#### FOR USE ON PEARS:

Dilute one gallon of Deccosol 122 Concentrate with 44 to 56 gallons of water. The pears are exposed to this solution for 1.5 to 4 minutes after which they are thoroughly rinsed with fresh water.

Once opened use the entire contents of this container within 120 days.

# STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

**STORAGE:** Store in a cool dry place.

**PESTICIDE DISPOSAL:** Pesticide, spray mixture or rinse water that cannot be used according to label instructions must be disposed of according to applicable Federal, State or local procedures under the Resources Conservation and Recovery Act.

Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.
