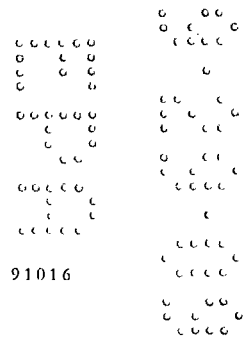

Once opened use the entire contents of the container within 120 days.

**FOR USE ON CITRUS:**

For use in mechanical foamers or sprays. Dilute one gallon of concentrate with 9 gallons of water. Contact time with citrus should be between 10 and 30 seconds. Follow treatment with adequate fresh water sprays. Also for use in the Decco Process by or under the supervision of DECCO US POST-HARVEST INC. personnel.

**FOR USE ON PEARS:**

For use in foam washers. Dilute 1 gallon of Deccosol 125 Concentrate with 11 gallons of water. This dilution is foamed and brushed onto the pears for 15 to 30 seconds after which it is thoroughly rinsed off with fresh water.
