### **CAUTION**

Harmful if absorbed through skin. Causes moderate eye irritation. Avoid contact with eyes, skin, or clothing. Prolong or frequently repeated skin contact may cause allergic reaction in some individuals.

### Personal Protective Equipment (PPE):

If you want more options, follow instructions for Category A on an EPA chemical-resistant category selection chart.

Applicators and other handlers must wear:

- chemical resistant gloves. Some materials that are chemical resistant to this product are barrier laminate, butyl rubber and nitrile rubber. If you want more options, follow instrucations for Category C on an EPA chemical-resistant category selection chart.

Follow manufacturer's instructions for cleaning / maintaining PPE. If no such instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry.

### **DIRECTIONS FOR USE:**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

### APPLICATION:

Decco 276 EC is applied at a 1% active ingredient level on washed and damp dried potatoes. The diluted material should be applied using spray nozzles placed evenly across the rollers on which the potatoes are being move.

### **DILUTION OF THE CONCENTRATE:**

Add 1 gallon of Decco 276 EC to 24 gallons of water and mix well. A milky white emulsion will develop. Use this diluted emulsion at a rate of 1 gallon per 8,000 lbs of potatoes. This is equivalent to 0.0104 lb ai/ 1000 lb potatoes. The maximum seasonal application rate for Decco 276 EC is 0.0104 lb ai / 1000 lb of potatoes.

#### NOTE:

Do not reuse the diluted material that was prepared 24 hours or more without mixing well.

Decco 276 EC sprout inhibitor is used for treatment of potatoes after harvest. Potatoes must be cured prior to treatment and, for maximum sprout inhibition, should be washed clean.

ENTRY RESTRICTIONS: Following application, workers (e.g. baggers) must wear chemical-resistant gloves while potatoes are wet.

### STORAGE AND DISPOSAL:

Do not contaminate water, food or feed by storage and disposal.

PESTICIDE STORAGE: avoid storage below freezing temperature. Prolong storage may result in gel formulation. Warming contents and agitation will restore material to useable conditions, but do not heat above 250 °F.

PESTICIDE DISPOSAL: Pesticide, spray mixture, or rinse water that cannot be used or chemically processed must be disposed of according to applicable Federal, State and local procedures.

CONTAINER DISPOSAL: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.
