DIRECTIONS FOR USE (Continued):

For aqueous spray, prior to any packout wax: Dilute one bag (575 grams) in 75 gallons of water to give about 2000 ppm of TBZ.

For citrus bin drencher: Dilute one bag (575 grams) in 150 gallons of water for a concentration of about 1000 ppm TBZ. The drenching of citrus in bins should continue for about three minutes. Use of a suitable wetting agent in preparing a sturry is recommended. Use one gallon liquid for spraying 1500-2000 lbs. of citrus or drench about 30 bins per 100 gallons of liquid. Avoid excessive foaming; use of antifoam is recommended.

For apples and pears: Decco Salt No. 19 can be used as an aqueous spray dip or drench on apples and pears. Use one bag of Decco Salt No. 19 (575 grams) for every 300 gallons of water to give a final concentration of about 500 ppm of TBZ. Do not treat fruit for more than three minutes.
