On the basis of information furnished by the registrant, the above named pesticide is hereby reregistered under the Federal Insecticide, Fungicide and Rodenticide Act. - Within the "Net Contents" section change "44.275 lbs" to "44.368 lbs".
- Within the "Precautionary Statements" delete the last sentence beginning with "Wear long-sleeved shirt......HE filter.
- Under "PPE" on page 2 change "handles" to "handler".

- Add NPDES statement to the Environmental Hazard section on page 2 because use creates a lot of effluent.
- Under "Application for Citrus", change "50 lbs" to "50 lb". Also, provide application method for each of the three types. For example, replace each "apply" with "apply by spray, dip, or drench" or any other correct method.
- Under "Application for Apples and Pears", within "For aqueous application" insert a "comma" after "an aqueous spray".
- Within the "Storage and Disposal" box insert "Pesticide" before the subheading "Storage". Also, under separate cover, change the "Container Disposal" to comply with PR Notice 2007-4.
- Under the "Warranty and Disclaimer" section replace "To the extent allowed by applicable law" with "To the extent consistent with applicable law".

This action is taken under the authority of section 4(g)(2)(c) of the Federal Insecticide, Fungicide, and Rodenticide Act, as amended. Reregistration under this section does not eliminate the need for continual reassessment of pesticides. EPA may require submission of data at any time to maintain the registration of your product.

Submit one (1) copy of final printed labeling incorporating the above changes before you release the product for shipment. Amended labeling will supersede all previously accepted labels. A copy of your label stamped "Accepted w/ Comments" is enclosed for your records.

Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of waste.

DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

GENERAL APPLICATION RESTRICTION:

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application.

APPLICATION FOR CITRUS:

For aqueous application:

Make a slurry solution by mixing of one 50 lbs bag of Decco Salt No. 19 with 200 gallons of water. Mix one gallon of the slurry with 29.5 gallons of water. This will give a 1000 PPM TBZ suspension. Apply this suspension to the fruit for up to 3 minutes. The slurry and the mixture should be kept under constant agitation to prevent TBZ precipitation.



For pack-out wax:

Use three bags of 575 grams each (or equivalent) of Decco Salt No. 19 in 130 gallons of wax to give a concentration of about 3500 PPM TBZ. Apply this mixture at a rate of 1 gallon to 8,000-10,000 lbs of cleaned citrus fruit.

Single application:

For an adequate sporulation control, use two bags of 575 grams each (or equivalent) of Decco Salt No. 19 in 60 gallons of wax to give about 5000 PPM TBZ. Apply one gallon of this mixture to 8,000- 10,000 lbs of citrus fruit.

Do not use this rate if the fruit had been treated with TBZ previously.

APPLICATION FOR APPLES AND PEARS:

For aqueous application:

Decco Salt No. 19 can be used as an aqueous spray dip or drench on apples and pears. Use one bag of 575 grams each (or equivalent) of Decco Salt No. 19 in 250 gallons of water to give a final concentration of about 600 PPM. Treat fruit with this concentration for up to 3 minutes.

For pack-out wax:

Use at concentration of up to 2000 PPM TBZ in pack-out wax. Apply at a rate of one gallon of TBZ / wax suspension to 10,000 lbs of clean apples or pears.

Use the following guide when mixing.

- Suspend one bag of 312 grams (or equivalent) of Decco Salt No. 19 in 55 gallons of wax to give a final concentration of 1500 PPM TBZ. Apply one gallon of this mixture to 10,000 lbs of clean apples or pears.
- II) Suspend one bag of 212 grams (or equivalent) of Decco Salt No. 19 in 55 gallons of wax to give a final concentration of 1000 PPM TBZ. Apply one gallon of this mixture to 10,000 lbs of clean apples or pears.
- III) Suspend two bags of 212 grams (or equivalent) of Decco Salt No. 19 in 55 gallons of wax to give a final concentration of 2000 PPM TBZ. Apply one gallon of this mixture to 10,000 lbs of clean apples or pears.

Apples may be treated before and after storage; pears may be treated once.

APPLICATION FOR POTATO:

Mist unwashed tubers on a conveyor line with tumbling action, entering storage with 5.67 grams of Decco Salt No. 19 to each 2000 lbs of potatoes in sufficient water for complete coverage. If additional treatment is necessary before shipping, mist the tubers at the same rate or dip the tubers for 20 seconds in a solution containing 5.67 grams of Decco Salt No. 19 per gallon of water. Minimum re-treatment interval is 30 days. Use of Decco 276 EC at label recommended rate is compatible with Decco Salt No. 19.

Seed potatoes should be treated before cutting. Maximum of one application for seed potatoes.



STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Store in a cool dry place.

PESTICIDE DISPOSAL: Pesticide, or spray mixture, or rinse water that cannot be used according to label instructions must be disposed of according to applicable federal, state or local procedures.

CONTAINER DISPOSAL: Completely empty bag into application equipment. Then dispose of empty bag in a sanitary landfill or by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.
