Dear Mr. Sales,

The amended labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided that you:

1. Make the following changes to the label:

a. In the second bulleted item in the in the "If swallowed:" subsection of the "FIRST AID" section change "...glass of water is able to..." to "...glass of water if able to...".

b. Change the name of the "If on skin:" subsection of the "FIRST AID" section to "If on skin or clothing:".

c. In the second bulleted item in the "If on skin [or clothing]:" subsection of the "FIRST AID" section change "...of water for 15 minutes..." to "...of water for 15-20 minutes...".

d. In the last sentence in the "FIRST AID" section change "...calling a poison control center or doctor going for treatment." to "...calling a poison control center or doctor or going for treatment."

e. In the sentence directly following "CAUTION" near the top of the second page of the label change "HARMFULED IF SWALLOWED..." to "HARMFUL IF SWALLOWED...".


f. In the first sentence in the second paragraph of the "PESTICIDE DISPOSAL:" subsection of the "STORAGE AND DISPOSAL" section change "In case of spill leak, cover spill or leak..." to "In case of spill or leak, cover spill or leak...".

2. Submit one copy of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration may be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

PESTICIDE DISPOSAL: Pesticide, or spray mixture, or rinse water that cannot be used according to label instructions must be disposed of according to applicable Federal, State or local procedures.

In case of spill leak, cover spill or leak with sand, vermiculite or similar absorbent; sweep up and dispose of pesticidal mix as indicated above. Flush and clean spill areas with water.

CONTAINER DISPOSAL: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or dispose of in a sanitary landfill, or by incineration if allowed by state and local authorities.

Application

In dips and wash tanks: Dilute with water at rate of 1 part of Deccoziil with 440 parts of water to give a treating concentration of 500 PPM Imazalil.

In bin or pallet bin drencher: Dilute 1 part of Deccoziil with 294 parts of water to give a treating concentration of 750 PPM Imazalil.

In non-recovery spray: Dilute 1 part of Deccoziil with 220 parts of water to give a treating concentration of 1000 PPM Imazalil. Apply to freshly cleaned citrus.

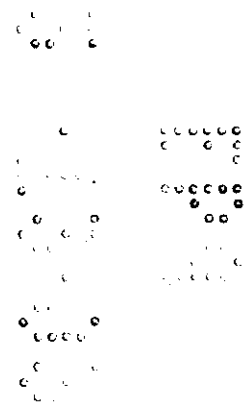
Foamer: Dilute 1 part of Deccoziil with 110 parts of "ready-to-use" diluted detergent material to give a treating concentration of 2000 PPM Imazalil. Apply to citrus from a mechanical foamer. Use only as much as needed to clean fruit.

In citrus packout wax: Dilute 1 part of Deccoziil with 110 parts of citrus packout wax (2000 PPM Imazalil). Use without further dilution in conventional waxing equipment.

In citrus storage wax: Dilute 1 part of Deccoziil with 110 parts of citrus storage wax, already diluted for use, and apply in conventional waxing equipment. This will give a treating concentration of 2000 PPM Imazalil.

NOTE 1 - Combinations of above listed applications can be made, but never more than two treatments should be carried out on the same lot of citrus.

NOTE 2 - For waxes and foamers, sporulation control can be obtained at 4000 PPM active ingredient. Dilute 1 part of Deccoziil with 55 parts of citrus wax or ready-to-use diluted detergent material to obtain this concentration. When this dilution is used, combinations of treatment are not allowed.
