**CONTAINER DISPOSAL:** Completely empty liner shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment. 1) For Peach, Plum and Nectarine

Mix 5 bags (3 lbs each) of Decco Salt No. 35 in 50 gallons of a suitable Decco Stone Fruit Coating. Apply one gallon of concentrate mixture on 28,000-30,000 lbs of fruit using a low-volume air nozzle spray system.

This mixture can be further diluted with water or Decco Stone Fruit Coating before application. Adjust the delivery on the nozzle system, if the mixture is diluted so no more than 3 lbs of Decco Salt No. 35 is applied per 28,000-30,000 lbs of fruit. Continuous agitation of the mixture is required.

2) For Cherries

Mix one bag (3 lbs) of Decco Salt No. 35 with 100 gallons of water or diluted Decco Stone Fruit Coating. One gallon of this ready-to-use mixture is applied to 4,000-5,000 lbs of cherries by non-recovery spray system. Continuous agitation of the mixture is required.
