- D. In the "First Aid Statement," under "If Swallowed," add: "Do not give anything by mouth to an unconscious person."
- E. At the top of page 2, beneath the signal word, delete the two sentences beginning with "Users should...."
- F. Correct the "Application Rate" table, on page 3, using a preferable convention for expressing values as "0.25 oz" or "0.25-oz." Also, ensure a unit (oz) follows each value.
- G. Beneath the table, following the text, delete what seems to be an arbitrary "\" slash.
- H. In the "Application Procedures" section, add: "**DO NOT** apply to fruit treated with diphenylamine prior to harvesting."

- J. Revise the first bullet, on page 4, so that it reads, "DO NOT breathe any fog."
 J1. Also, delete the extraneous 'A' from the fourth bullet's sentence. From this fourth bullet, establish an additional bullet for its second sentence. This bullet must appear as the fifth bullet to this section.
- K. In the "Re-entry" section, on page 4, change "...in addition to PPE listed..." to, "...in addition to PPE (except full face respirator) listed"

Preparation of DPA Aerosol

- > Calculate the amount of DPA Aerosol according to the table above.
- > Weigh the amount to the nearest gram into a 1-gallon stainless steel container.
- > Cover and place the container on an electrical heater and melt the DPA Aerosol at 180°F

Thermal Fogger Operation

- Place the thermal fogger machine horizontally outside the treatment room at a height of about 3 feet from the floor. Cover the door or window to the treatment room with a plastic sheet and insert the fogging pipe through a hole in the plastic. Seal the opening around the nozzle with duct tape.
- Adjust the pump and mount the nozzle to deliver up to120 mL per minute.
- Turn on the thermal fogger machine
- Insert the insulated input pipe into the molten DPA Aerosol. Start the pump. Keep the molten DPA temperature at 160-180F

Application Procedures

- Avoid breathing the fog
- Turn off room cooling systems and humidifiers 12 hours prior to and during treatment
- Turn off room circulation fans immediately prior to and during treatment
- A Turn on room circulation fans one hour after the treatment. Allow the fog totally to disappear (about 5 hours post-treatment) before restarting cooling systems
- DO NOT rinse apples after treatment
- DO NOT use treated apples for pomace or livestock feed as illegal residues may occur in meat or milk
- DO NOT wrap apples in Diphenylamine-treated paper
- Fruit must have shipping carton marked: "Treated with Diphenylamine to retard spoilage."

Re-Entry

Entry into the treatment area by another person other than properly trained and equipped handlers is prohibited from the start of application until the treated area is ventilated as follows:

- 8 hours with no ventilation followed by 1 hour of mechanical ventilation
- 24 hours with no ventilation

In case it is necessary to enter the treatment area during treatment or before ventilation requirements have been met, handlers must wear chemical resistant headgear and a self-contained breathing apparatus (SCBA, MSHA/NIOSHA approval number prefix TC-13F) in addition to PPE listed under the PRECAUTIONARY STATEMENTS.

Check for Post-Treatment Signs of Scald

In years of severe scald development, Decco DPA Aerosol may not give desired control or other factors may reduce its effectiveness. After several months of storage, collect samples of fruit periodically (every 2 or 3 weeks) and hold them at room temperature to assess scald development. Fruit lots showing scald can often be marketed immediately.

STORAGE AND DISPOSAL
