PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS

DANGER

Corrosive, causes eye damage and skin irritation. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and rubber gloves when handling. Harmful if swallowed.

FIRST AID

STORAGE AND DISPOSAL

PROHIBITIONS: Do not contaminate water, food or feed by storage or disposal. Open dumping prohibited. Do not reuse empty container.

PESTICIDE DISPOSAL: Pesticide, that cannot be used or chemically reprocessed, should be disposed of in a landfill approved for pesticides or buried in a safe place away from water supplies.

CONTAINER DISPOSAL: Do not reuse empty container. Return to drum reconditioner or destroy by perforating or crushing and burying in a safe place.

In cotton, spun rayon or polyester fabrics or blends thereof, a level of from 2% to 5% DUROTEX will afford excellent protection against attack by surface growing bacterial and fungal organisms.

The higher level of protection is recommended for use in fabrics which will be subjected to weathering. For such applications the use of a water repellent or resin binder is recommended. Many commercial water repellent formulations, as well as binders such as PVA or acrylics, are compatible with the DUROTEX compounds, and will greatly aid in the creation of a more durable system.

For mattress ticking fabrics a level of 2% to 3%, based on the finished weight of the fabric, is recommended. A resin binder such as PVA or acrylic cleared for textile use by the FDA should be employed.

For the protection of adhesives (non-food grade), latex emulsions, and similar systems, a level of 0.75 to 2% is sufficient to protect the product against bacterial or fungal deterioration.
