For certain vinyl items which may be subjected to extended outdoor weathering, a level of 3 - 5% VINYZENE IT 3000 DIDP (3 - 5 lbs/100 lbs compound) should be evaluated. Such items would include vinyl tarpaulins procured by military and naval agencies for protection on items subjected to extended outdoor storage.
