Normal rainfall following application will not adversely affect results. Resume keeping soil moist day after application and especially during hot, dry weather.

NEW TURF should not be treated until the third mowing. DAL-E-RAD+2 is best to apply early summer after Dallis Grass has come up. Since all seeds do not germinate at the same time, it may be necessary for one or more additional treatments at 10 to 14 day intervals.

Do not use on St. Augustine, Carpet, Centipede, Bent, Dichondro and Rabin granges

dra and Bahia grasses.

Should the Bermuda or Zoysia Turi discolor, normal color will return in a few days.

Clean equipment after use by flushing with water. Run rinse

water in area away from domestic water sources.
