

PRECAUTIONS: Do not spray flower beds, borders, or shrubbery. "Vi-Pex" is a plant killer. Avoid allowing spray to drift over flowering plants, vegetable gardens, etc. Course sprays are less likely to drift. The first mowing after treatment should not be used as a mulch for flowers and vegetables.

Wash out the spray equipment before using "Vi-Pex". After use, rinse equipment including nozzles thoroughly with water containing a wetting agent or detergent fluid; refill with clean water and let stand overnight. Empty spray equipment the following day.

Ponds, streams, rivers and water sources **MUST NOT** be contaminated with the concentrate solution or spray washings.

To allow for best absorption of the chemical by the weeds, avoid cutting or mowing turf for at least one day before and after spraying. Water sprinklers should not be used for 24 hours after spraying.

GENERAL INFORMATION

"Vi-Pex" is a stable aqueous solution containing the potassium salt of MCPP, equivalent to 40 ounces of acid per gallon. It is non-flammable. "Vi-Pex" may be used on grasses such as bluegrass, bentgrass, bermuda-grass, fescue, for control of many broadleaf weeds such as:

DIRECTIONS

TIME OF APPLICATION: Apply in warm weather under good growing conditions. Some injury to turf may result if this product is applied in very hot weather (over 90 F.) or in drought conditions. This product must be mixed with water prior to use.

APPLICATION RATES:	Per 1000 Sq. Ft.	Per Acre
Established Greens	1½ fluid oz. in 2 gals. of water	4 Pints in 30-40 gals. of water
Established Turf & Fairways	1½-2¼ fluid oz. in 2 gals. of water	4-6 Pints in 30-40 gals. of water

MIXING: In order to ensure even mixing fill half the spray tank with clean water. Add required amount of "Vi-Pex", mix thoroughly and finally add more water as required. It is not necessary to add a sticking agent to "Vi-Pex".
