DIRECTIONS FOR USE

Apply VINELAND MBT 30% in paper mills at the rate of 2/3 oz. to 2-2/3 oz. by weight per ton of finished paper. Add intermittently or continuously depending on mill requirements. Apply at point well ahead of area of need and where immediate dispersion or water solution not required, preferably where stock is of high consistency such as beater, hydropulper, and broke chest.

VINELAND MBT 30% may be used to make more dilute formulations by the addition of suitable solvents and/or dispersing agents.
