DIRECTIONS FOR USE

For rapid control of roaches, ant, spiders, crickets, silverfish, centipedes, cheese mites, meal worms, grain beetles (confused flour beetles, red flour beetles) and weevils (granary weevils, rice weevils): Apply in a good sprayer adjusted to deliver a coarse wet spray, at a rate of 1 gallon to 750 square feet of surface. Direct spray into locations where these insects are found; garbage compactors, garbage chutes and cans, into cracks and crevices, dark corners, behind and beneath sinks, stoves, refrigerators, and cabinets, along baseboards, and around door and window frames. Spray ant trails, nests and points of entry. Spray insects directly wherever possible.

In case of infested foods in cabinets, dispose of the infested material. Remove all contents and clean thoroughly. Spray interior surfaces of empty cabinets thoroughly. After spray has dried, cover shelves with paper or otherwise protect foods from direct contact with sprayed surfaces.

Repeat treatment if reinfestation occurs. To kill flies including fruit flies, mosquitoes, gnats, flying moths, wasps and hornets: Close windows and doors and shut off ventilating systems. Remove pets, birds and cover fish aquaria before spraying. Apply as a fine mist using a non-thermol sprayer. Thoroughly fill the area with mist with special attention to light sources which attract these insects. Keep area closed for 15 minutes. Vacate treated area and ventilate before reoccupying.
