DIRECTIONS

Add two fl. oz. (60 cc) of Matt-Kleen disinfectant cleaner to one gallon of warm water and mix well. Apply with a cloth or mop and wet entire surface thoroughly, then wipe clean. No rinsing is required. For added convenience, a pump sprayer may be used; simply spray until thoroughly wet and wipe clean. For heavy soil or organic matter, a pre-cleaning step is recommended. **Note:** Be sure to follow dilution directions carefully. Changing the ratio of Matt-Kleen to water may reduce its effectiveness or cause damage to surface being cleaned.

STORAGE AND DISPOSAL

Store in original container placed in locked storage area in a dry place no cooler than 50°F or warmer than 120°F. Do not reuse empty container. Wrap empty container and put in trash.

WARNING

FIRST AID

In case of contact, immediately flush eyes or skin with generous amounts of water for at least 15 minutes. For eyes, call a physician. Remove and wash all contaminated clothing. If swallowed, drink milk, egg white, gelatin solution. If these are not available, drink large quantities of water. Call a physician.
