- 3. You need to redesign your graphic showing a user handling the product with the person's bare hands. You need either to delete the graphic or show the person grasping the product through the plastic package.
- 4. Remove the "s" from "Active Ingredients"

For the 4 oz size, you need to submit revised labeling with references to closets removed.


