The proposed amendment to the registration of the product cited above under the Pederal Insecticide, Fungicide, and Rodenticide Act, removing the active ingredient MGK R-11 and increasing the percentage of another active ingredient, is acceptable subject to the comments listed below. A stamped copy of the label is enclosed for your records.

- 1. Submit the product-specific product chemistry and data matrix for the new formulation.
- 2. Based on the current Confidential Statement of Formula (CSF) dated June 20, 1990, the product will not meet the label claim for the active ingredients. On the CSF you claim 0.46% for the certified lower limit for both MGK Repellent 326 and MGK 264; however, on the label you claim 0.50%. The amount claimed on the label must be the same as the certified lower limit. Submit a revised CSF or correct the label so that they agree.
- 3. Provide the chemical identity of Fragrance MP0824. All chemical components of the fragrance must be identified by Chemical Abstracts Service (CAS) Number and percentage in the mixture. Submit the CAS Number for the fragrance along with a Material Safety Data Sheet for the fragrance.

- 4. The statement "Keep Out Of Reach Of Children" must appear directly above the signal word "Caution" on the front panel.
- 5. Add the statement "Do not puncture or incinerate" to the Storage and Disposal statement.
- 6. Add the following precautionary labeling:

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS

CAUTION

For external use only. Harmful if swallowed. Avoid breathing spray mist. May cause eye irritation. Avoid contact with eyes, lips or open cuts. Do not expose treated skin or clothing to fire, sparks or flame until liquid has evaporated. Do not allow children to rub eyes if hands have been treated.

7. Add the following Statement of Practical Treatment:

STATEMENT OF PRACTICAL TREATMENT

- If In Eyes Wash with plenty of water. Get medical attention if irritation persists.
- 8. Submit a 1-year storage stability study. The formulated product must be analyzed for its active ingredients at time zero and during a year of storage. The storage must be under warehouse conditions of temperature and humidity using containers similar to those that will be used in the trade. This data must be submitted within 15 months of the date on which this product is finally registered.
