20% Sabadilla Dust may be applied at any time during the day suitable for dusting. It is effective for the control of the Southern green stink bug, harlequin bugs, lygus bugs, squash bugs, tarnished plant bugs, chinch bugs, leaf hoppers, cabbage looper, and imported cabbage worm.

Apply Sabadilla Dust at the rate of 15 to 30 pounds per acre depending on the infestation present and the state of plant growth. Use a good dust gun and apply insecticide to both upper and lower leaf surfaces.
